<ol style="list-style-type: none"> Must be a United States Citizen Must be a registered voter on the date of election Must be a resident of the City of Plano for one (1) year prior to the date of the election Must be a minimum of 21 years of age Have not been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated; or partially mentally incapacitated without the right to vote Have not been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities Must satisfy any other requirements prescribed by law or City Charter for the office Candidates must be nominated by petition per City Charter and state law: City of Plano Code of Ordinances Application*, Petition* and Nomination Form must be filed together by the filing deadline Candidate Packets are available in the City Secretary's Office the first week of January in odd years. Candidates are strongly encouraged to obtain a candidate packet. 	February 12, 2021 by 5:00 PM
